

DDAA ANNUAL MEMBERSHIP MEETING SUNDAY, MARCH 23, 2014 CRYSTAL GATEWAY MARRIOTT ARLINGTON, VIRGINIA

MINUTES

DDAA President Sherry McDavid called the meeting to order at 12:45 p.m. and welcomed those present. She mentioned the large crowd due to lunch and stated this was the first Annual Membership meeting she had attended without Tom Hunter present.

President McDavid introduced Appalachian Regional Commission Interim Director Charlie Howard. Mr. Howard expressed appreciation to those in attendance. He introduced the DDAA Officers and complimented them, along with other Board members upon a successful year. He then welcomed all LDD Executive Directors especially new ones. He expressed appreciation for Tom Hunter, who he mentioned had retired after 20 years of service with the ARC. He mentioned that ARC is currently in the process of finding a new Executive Director. He stated that FY'2014 Appropriations for ARC are at \$80.3 million with \$10.0 million for broadband projects in coal impact areas. He stated that grant contracts have gone out last week and this week and payments will follow shortly. Mr. Howard mentioned that the 50th anniversary of the ARC will be March 9, 2015 and he spoke of the role of the LDDs in making ARC a success over the years. He then presented a PowerPoint presentation about ARC with data about the programs impact in FY'2013.

Mr. Guy Land, ARC Chief of Staff, spoke some about Tom Hunter as well and stated he was glad Charlie Howard agreed to serve as Interim Director. Mr. Land introduced Earl Gohl, ARC Federal Co-Chairman and Jim Byer, Alabama Governor Bentley's alternate. Mr. Land mentioned that Cameron Whitman was no longer the States' Washington Representative and the states have advertised for the position and will be selecting someone in the Spring of 2014. He mentioned the FY'2014 ARC appropriation of \$80.3 million with \$10 million going to the coal impacted areas of central Appalachia and discussed the President's FY'2015 budget level request for ARC of \$68.2 million which would include level funding for the LDDs. He stated that time year's budget bill took a lot of uncertainty out of the FY'2015 appropriations. He stated that ARC is part of the Energy and Water bill in the House and stated that there was an amendment offered last year to eliminate ARC is likely to come up again this year but he feels ARC is in pretty good standing for FY'2015.

Regarding ARC reauthorization, Mr. Land felt that it looks more favorable to happen this year. He stated MAP-21 will expire in the fall of 2014 and feels a new bill will not pass but instead an extension of the existing bill will be approved. He then spoke of all the interagency program cooperation going on in Washington DC and stated he has never seen this level of cooperation. He mentioned that 4 LDDs are a part of Make it in America Challenge Grants that were funded and stated that all applications for Livable Communities had an LDD as a partner. Lastly, Mr. Land advised that 2 initiatives that will be forthcoming are the Made in Rural America Initiative and an export initiative as well.

President McDavid called the meeting to order and asked for approval of the agenda. Eric Bridges/Pennsylvania made a motion to approve the agenda and Misty Casto/Ohio seconded the motion. The motion passed unanimously.

Ms. McDavid then asked for approval of the minutes of the 2013 Annual Meeting. Danny Lewis/Georgia made a motion to approve the minutes and Mike Patrick/Kentucky seconded the motion. The motion passed unanimously.

Treasurer Steve Pelissier/South Carolina presented the Treasurer's Report to the membership and gave a brief history of the DDAA Treasurer position. The DDAA is in sound financial condition. He provided a copy of the FY2014 Annual Budget status and the proposed FY2015 Annual Budget. Mr. Pelissier's financial report and the FY2015 proposed budget were reviewed and recommended for approval by the DDAA Board of Directors earlier in the day. Supporting the recommendation of the Board of Directors, Susan Reid/Tennessee made a motion to approve the Treasurer's Report and the FY'2015 DDAA Proposed budget and Rudy Johnson/Mississippi seconded the motion. The motion passed unanimously. (See Attachment 1).

Training Committee Chair Misty Casto/Ohio thanked Dan Neff for all he does to make the Annual Conference happen and named all of the Training Committee members. Ms Casto discussed the upcoming Professional Development Conference agenda and also discussed the SERDI New Executive Directors' Training event. She advised that scholarships would be available through DDAA for any Executive Director who had been in their position less than 3 years at a DDAA member district. She also mentioned that DDAA will be co-sponsoring the NADO Economic Development Finance Service and Rural Transportation Planning Conference in Cincinnati, Ohio in December 2014.

President Sherry McDavid/Kentucky then introduced Mr. Danny Lewis/Georgia, Immediate Past President, who presented the slate of officers for the upcoming year. They include:

2nd Vice President - John Hemmings Secretary - Richard Zink Treasurer - Steve Pelissier Mr. Lewis made a motion that the slate of officers be approved and Susan Reid/Tennessee seconded the motion. The motion passed unanimously.
